
The number of people using tablets and smart phones to access the POTI website has tripled since 2010!

Two Courses on SCR 1325 with Video Available at No Cost

POTI is pleased to announce the free worldwide availability of two e-learning courses through a generous grant from the Australian Government. *Implementation of SCR 1325 (2000) in Africa*; and *Implementation of SCR 1325 (2000) in Latin America and the Caribbean* were both developed by the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women) and the Peace Operations Training Institute (POTI). Security Council resolution 1325 (2000), unanimously adopted in October 2000, sets out a policy framework for women and peace and security. These courses introduce the main principles of the resolution and provide practical guidelines on how to implement it at the national level, including through the development of national action plans.

Students who enroll in either of these courses will also be directed to view the video, *Side By Side:*

Women, Peace and Security which was funded by the Australian Government and UN Women.

Ambassador Ellen Løj Joins POTI Board of Directors



Ambassador Ellen Margrethe Løj, then Special Representative of the Secretary-General to Liberia, and Major General Mohammad Khalid, Force Commander for the United Nations Mission in Liberia (UNMIL), greet the UNMIL contingent from Pakistan, based in Harper, southeast Liberia.

POTI is pleased to announce that Ambassador Ellen Løj, of Denmark, has joined the POTI Board of Directors. Ambassador Løj began her career with Denmark's Ministry of Foreign Affairs in 1973. From 2001 to 2007, Ambassador Løj served as the Permanent Representative of Denmark to the United Nations. She also represented the EU in the UN during Denmark's Presidency of the EU in 2002, and served as Chairman of the Security Council's Sanction Committee on Liberia 2005–2006, and as Chairman of the Security Council's Counter Terrorism Committee 2005–2006.

From 2008 to 2012, Ambassador Løj served as the Special Representative of the Secretary-General (SRSG) for the peacekeeping mission in Liberia. She was responsible for all operations of UNMIL, comprised of 8,000 military personnel, 1,400 police, and 1,500 civilians. Ambassador Løj has an MA in Political Science from the University of Copenhagen, and resides in Denmark.

Ambassador Løj's experience and dedication towards peacekeeping make her an excellent addition to the BOD team. Welcome Ambassador, we look forward to working with you.

Brindisi Conference: Expert Consultations on Child Protection Training for Peacekeepers

On the sunny Italian coast, representatives from the United Nations, national peacekeeping training centres, and related non-profit organizations met to discuss a far more serious topic than was belied by the warm Mediterranean surroundings: the training of peacekeepers on child protection. What may seem like a straight forward subject, the protection of children during times of conflict and immediately following conflict, is actually a topic fraught with subtle nuances. Children's experiences during conflict can differ greatly; some may have been victims of horrible atrocities and separated from their parents,

while others may have been combatant aggressors. The need for peacekeepers to understand the varied experiences of children, along with the different ways that children process this information from adults, is key as peacekeepers and other humanitarian actors may be the only adults who can help these children recover and return to a productive society.

The Department of Peacekeeping Operations' *Expert Consultations on Child Protection Training for Peacekeepers* was held at the United Nations Logistics Base (UNLB) in Brindisi, Italy, from 28–30 March 2012. Through three days of discussions, presentations, and group projects, experts, including POTI's Chief of Course Content, Lauren Butt, examined the most effective ways of training military, police, and civilians on child protection. Lauren was asked to make a plenary presentation, during which she spoke about possible entry points for child protection training using distance learning. Those present acknowledged the efficiency and efficacy of e-learning for providing at least baseline knowledge on the subject and were impressed with POTI's training record. The workshop generated many productive ideas that will hopefully lead to coordinated training projects in the future.

For more on child protection, look for POTI's upcoming course *Protection of Civilians*, due out by the end of 2012.

Six more

training centres have become Certificate-of-Training in United Nations Peace Support Operations (COTIPSO) partners with POTI during the first half of 2012. 
Human Rights

This course is a comprehensive historical overview of the theory and practice of human rights, a term used to describe rights and entitlements that inherently belong to every human being. Although all human beings are entitled to these rights equally, history has shown that all people do not enjoy the same protection of their rights at all times. This course explores the different kinds of human rights, the various international and regional documents necessary to protect and enforce them, and the historical difficulties and conflicts that have occurred in spite of, and often because of, human rights. It includes extensive discussions on the development of the various human rights treaties and enforcement mechanisms, the special protection given to vulnerable groups, human rights during armed conflict, and current debates involving human rights, such as the use of technology either to promote or restrict human rights, and the increasing international significance of stateless actors like transnational corporations and terrorist groups. Fifteen lessons, 356 pages.

Human Rights and Peacekeeping



This course examines the cross-cutting principles and obligations concerning human rights within the specific context of armed conflicts and United Nations peace operations. Human rights is a dimension that transcends all phases and employs all components of a peace operation, leading to often complex implementation planning and coordination, which this course traces and delineates. The course begins by reviewing the landmark documents and instruments indispensable to the protection of human rights in theory, before demonstrating how such protection is enforced and performed on the ground. It discusses the various types of human rights violations, identifies the groups of people especially at risk, and conducts a thorough analysis on the concept of protection – the core of human rights work in peace operations. The course contains important sections on human rights partners – a group that includes such external actors as NGOs and international businesses – and on the process of accountability, which, as the course demonstrates, is

essential in peace operations if an established peace is to be long-lasting and sustainable. Ten lessons, 284 pages.

COURSE AUTHOR: Patrick Marega Castellan is a human rights consultant who has served in various capacities – including specialist, adviser, and trainer – for United Nations missions in Haiti, Darfur, Angola, and Liberia. He is based in Papua New Guinea.
